The Participant and/or Participant's parent or legal guardian hereby agrees to indemnify and defend CoOP against all claims, causes of action, damages, judgements, costs or expenses, including attorney fees and other litigation costs, which may in any way arise from the Participant's participation in the subject event.

The Participant and/or the Participant's parent or legal guardian understand and agree that the Participant and/or the Participant's parent or legal guardian is responsible to pay for all damages caused by any negligent, reckless, or willful actions by the Participant, the Participant's invitees, the Participant's family members and/or the Participant's parent or legal guardian.
